### **Wetland Restoration Officer**

Rewilding Europe is seeking a Wetland Restoration Officer to advance wetland restoration in the Romanian part of Danube Delta. Such restoration is part of Rewilding Europe's strategy to rewild the Danube Delta in Romania, Ukraine and Moldova, with the enhancement of wild nature creating new sources of income for local communities and delivering positive social impact.

The Danube Delta is one of Rewilding Europe's rewilding areas. The Wetland Restoration Officer will be a member of the Rewilding Danube Delta team, an independent entity registered in Tulcea (Romania). However, he/she will report to the Rewilding Europe rewilding team and colleagues that execute wetland restoration projects within the Rewilding Ukraine team.

The successful applicant will contribute to the delivery of an ambitious and wide-reaching vision, help to develop innovative strategy, collaborate closely with talented co-workers, and deliver tangible conservation results in the cross-border Danube Delta area.

# **Position summary**

The Wetland Restoration Officer will help to boost restoration in the Danube Delta, working with a range of stakeholders to lobby for, plan, develop and implement wetland restoration projects.

The officer will preferably be based in the Danube Delta area or nearby, although this is not absolutely essential.

- analyse opportunities and risks for wetland restoration in the Danube Delta
- support different partners in the preparation of strong wetland restoration proposals  $\,$
- develop detailed wetland restoration projects and budgets to seek funding opportunities
- identify possible funding opportunities
- Prepare technical and communications reports
