## **POSSITION SUMMARY**

The RM ensures the implementation of Rewilding Europe's main strategy and objectives for the Rhodopes rewilding area based on vision for the area. RM works for further wildlife comeback in Rhodopes through supporting existing species populations and through reintroduction of missing key species, including bisons, deer, wild horses etc., to establish viable populations of an original, native species composition.
